VMDA ACHIEVEMENTS

VMDA is pro-active in representing its members, and has achieved some major successes.

VMDA has been involved with the APVMA Manufacturers Licensing Scheme from its conception stage in the early 1990s. This involvement has helped ensure that it did not damage Australian industry, but at the same time achieved the APVMA objectives. The end result – good 'Australian Made' products.

Training is not only an important aspect of our industry, but is necessary for anyone selling and recommending veterinary chemicals. The VMDA's Veterinary Industry Training Course is tailored to the veterinary market, recognized by government and industry, and accredited by Agsafe, if required.

VMDA has successfully mediated with the AVPMA to ensure favourable outcomes, especially for Australian-based manufacturers and registrants.

Areas of particular importance include Manufacturers' Licensing (our own Australian code of GMP), Free Sale and Export Certificates (more user friendly and supportive of the exporter), Adverse Experience Reporting Program (more streamlined and self-regulating), and Label Changes (more practical and simplified).

VMDA is also a major contributor to practical environmental reforms through its membership of DrumMuster and ChemClear 'clean waste/drum' collection programs funded by a levy on sales of farm chemicals to alleviate environmental contamination by empty chemical containers.

VMDA's prestige with key Government entities has ensured that we have involvement in drafting of policy on issues of concern to our industry.
